On days on which events are being held at Hampden Park in Mount Florida, there is widespread illegal parking. This causes huge difficulties for residents. Mount Florida Community Council has

received many reports of residents detailing drivers illegally parking and being confrontational when challenged. When advised that a parking fine would be levied, residents are told that the fine could be easily split and shared by the vehicle occupants.

It is clear that the current levels of parking fines are not working as a deterrent. The current fines, when shared between a car full of people, amount to a relatively modest parking charge rather than a fine. This renders our entire community as an affordable car park for stadium attendees.

Increasing the penalties will ensure these fines are not simply an additional cost to drivers intending to park illegally, but a genuine deterrent.
